  - i. Kerry noted that we're silent on a role for COVID-END in terms of long-term health and socio-economic consequences of COVID-19 and that at UNICEF they see a COVID-19 focus shifting from a standalone one, to being integrated as a lens within ongoing programmes, but the long-term focus is still explicitly there
  - ii. Jeremy noted that one task for the next 12 months is to develop a 'succession plan' for COVID-END how can we develop COVID-END like support across sectors and the world (we anticipate many COVID-END partners will (should) be involved.
