Review preliminary results from the COVID-END baseline study conducted by the Sustaining working group The objectives of the baseline study that the Sustaining WG is conducted are: 1) To understand how the evidence synthesis organizations, members of the COVID-END network, initially responded to the COVID-19 pandemic 2) To understand their experiences of involvement in the COVID-END network The qualitative semi-structured interviews part of the baseline study covers the second objective and the focus in the qualitative study is mainly on the response of each organization to the pandemic, and their experiences and involvement of engagement within COVID-END Codebook developed from the semi-structured interviews had 4 overarching codes/themes emerge: o Involvement, which looks at how the organization approached to join the network Expectations, examines the reasons for the organization joining the network Experiences, which asks participants to reflect on their participation in COVID-END Improvements, which looks at what could be done to improve organization's involvement with the network and improve COVID-END Preliminary results illustrate potential next steps for the Recommending WG, such as: o Closing the gap in the evidence reviewers and the guideline developer Avoiding duplication of work Is there a role for COVID-END to use what is happening in the collaborative as a case study to get at these specific examples that are coming out of the qualitative interviews (e.g., avoiding duplication of work, closing the gap)? Should the WG engage more HTA researchers and bringing them into the working group to enrich and move forward the discussion?
