### **Our products**

The Forum prepares timely, demand-driven evidence products addressing a wide array of priority health- and social-system topics (rapid evidence profiles, rapid syntheses, evidence briefs and citizen briefs), products that capture insights from our stakeholder dialogues and citizen panels (dialogue summaries, panel summaries and videos of interviews with dialogue participants), and living versions of these products to keep them relevant when the evidence, issue or context is evolving quickly. The Forum also prepares evidence syntheses as 'global public goods' that synthesize what is known based on the best-available evidence globally for a particular research question, including how what is known varies by groups and contexts. # Find domestic evidence through our own products

## **Contextualized evidence syntheses**

The Forum has produced 200+ timely and demand-driven contextualized evidence syntheses for federal and provincial governments in Canada (including several government agencies), key health- and social-system stakeholders (e.g., health authorities and professional associations), citizen-serving organizations and international agencies. Our approach can be used to provide insights from the best-available evidence in ultra-rapid timelines (i.e., within days), or longer (weeks or months) and can adopt a 'living' approach where enhancements to scope and methods can be incorporated over time and used to evolve to 'global public goods'. Our contextualized evidence syntheses are also prepared in a way that includes a combination of different analyses to inform issues at different stages of the policy cycle, such as a policy analysis of the best-available evidence and system analyses (e.g., through jurisdictional scans) that provide insight into experiences of jurisdictions with addressing pressing policy issues.

# **Spark action** through stakeholder dialogues, citizen panels and more

## Stakeholder dialogues

In 2009, the Forum pioneered the use of stakeholder dialogues – a form of deliberative process – to spark action on pressing health-and social-system challenges. Each dialogue is informed by a pre-circulated, context-specific evidence brief that mobilizes the best available local and global evidence about a problem and its causes, options for addressing it, and key implementation considerations and when preceded by a citizen panel on the same topic it also includes citizens' insights. Deliberations – which can be in-person or virtual – elicit the tacit knowledge and real-world views and experiences of government policymakers, system and organizational leaders, professional leaders, and leaders from citizen-serving organizations aiming to identify next steps for different constituencies. The Forum has convened more than 75 dialogues to date and documented their impacts on a range of advisory and decision-making processes.

#### Citizen panels

Having identified citizens' values and preferences as a missing ingredient in most advisory and decision-making processes, the Forum began convening citizen panels in 2013, initially as a stand-alone process but increasingly as an input to stakeholder dialogues where citizens' input can help to shape deliberations about how to address pressing challenges. Each citizen panel is informed by a pre-circulated citizen brief and comprised of citizens who reflect diversity both in lived experience with the issue at hand and in their age, gender, ethnocultural background and socioeconomic status. The Forum has convened 36 citizen panels to date and documented how they've shaped both stakeholder deliberations and advisory and decision-making processes.

# Leverage networks

In addition to delivering our own programs, the Forum plays many roles in strengthening health and social systems. Over the years we've worked closely with a remarkably diverse array of individuals and organizations who share our interest in collaboratively addressing critical health- and social-system challenges.

# Rapid-Improvement Support and Exchange (RISE)

RISE's vision is a rapid-learning health system that continually 'ups its game' in achieving equity-centred quadruple-aim metrics. Its mission is to contribute to the Ontario Ministry of Health's Ontario Health Team (OHT) Central Program of Supports by providing OHTs with timely and responsive supports for rapid learning and improvement (e.g., through coaching and the preparation of peer profiles that facilitate peer sharing and learning about OHT acceleration priorities), on-demand products and processes (e.g., RISE briefs and jamborees) and tools and resources (e.g., a comprehensive website for resources to support OHTs and a monthly newsletter and events calendar).

The Forum's director has edited a book answering the commonly asked question: how does the Ontario health system work? The book – entitled 'Ontario's health system: Key insights for engaged citizens, professionals and policymakers' – can be purchased through Amazon or key chapters can be downloaded for free from the RISE website.

#### **COVID-19 Evidence Network to support Decision-making (COVID-END)**

COVID-END was a time-limited network that brought together more than 50 of the world's leading evidence-synthesis, technology-assessment and guideline-development groups around the world. It covered the full spectrum of the pandemic response, from public-health measures and clinical management to health-system arrangements and economic and social responses. It also covered the full spectrum of contexts where the pandemic response was playing out, including low-, middle- and high-income countries.

## **Global Commission on to Address Societal Challenges**

The Global Evidence Commission began in April 2021 as a grassroots effort to improve the use of research evidence, both in routine

times and in future global crises. Our Implementation Council grew to be 95 organizational partners strong, and drawn from 18 countries in every part of the world and from many global and regional bodies. The Citizen Leadership Group brings together citizen leaders and leaders of citizen-serving organizations to advance the Global Evidence Commission's implementation priority to put evidence at the centre of everyday life. Important aspects of its work have now been taken up by the <a href="Evidence Synthesis">Evidence Synthesis</a> Infrastructure Collaborative.
